
Recent reports indicate that a new "Imposter Scam" is circulating throughout South Texas. Local residents have been contacted via text, email, or phone call by individuals posing as law enforcement agents from the FBI, Federal Trade Commission, or other organizations, such as Microsoft.

The scammers then instruct their targets to withdraw large sums of cash from their financial institutions and deposit it into a Bitcoin ATM using a QR code.

We urge everyone to remain vigilant in protecting their personal information. Regularly monitor your accounts through online banking or mobile apps.

If you receive communication from an unknown phone number or email address, DO NOT ENGAGE. Always contact the legitimate entity directly to verify any claims.


