The Texas Bridge Credit Union Board of Directors will determine the number of and dollar amount of scholarships that are to be awarded.

To be considered for the scholarship, a student must provide the following information. If any information is missing or not provided, it may result in disqualification of the applicant for this scholarship.

- <u>The applicant and/or their parent(s) or legal guardian(s) must be a member in good standing at</u> <u>Texas Bridge Credit Union when submitting the application. Employees and Board Directors of</u> <u>Texas Bridge Credit Union are not eligible for this scholarship program.</u>
- TXBCU scholarships will be awarded to a recipient a maximum once per calendar year in the high school senior and post-secondary categories.
- Applicants must sign an authorization and/or consent waiver agreement for the use of their name and photo in future advertisements of scholarship recipients by Texas Bridge Credit Union.
- Be currently enrolled or planning to enroll in an accredited community college, 4-year college or university, or a program leading toward a GED or vocational or technical degree.
- Be enrolled in a minimum of six (6) college credit hours per semester.
- Submit an essay.
- Completed applications must arrive at the Texas Bridge Credit Union Holly office by the close of business, <u>Friday, March 28, 2025 at 5:00PM</u> of the current year (for the Fall Semester 2025) for full consideration of the selection committee. <u>Applications submitted after the stated deadlines will not be accepted.</u>
